#### A Snapshot:


- I possess hands-on and current practical techniques for contract negotiations and the raising of capital. Recently, during
  the past 4 years, I led contract and negotiation teams for several different projects, including aviation, defense,
  commodities, and agriculture resulting in several contract proposals and one IDIQ, all roughly totaling \$715 million. This
  would only be possible through a stellar interconnected professional and global network where marketing and research
  efforts are seamless and where relationship quality and integrity set the bar high. These projects require extensive
  experience in business development and capital raising which include both traditional and non-traditional financing
  options.
- Additionally, I successfully structured smaller projects involving solopreneurs, partnerships, LLC's and S and C corps that revolve around supply chain and supply chain management, import and export, tech transfer and service based businesses. These led several businesses into new markets such as Japan, Korea, and Dubai. These types of clients require much more hand holding and need more personalized efforts to develop their businesses and also need to take advantage of small business opportunities through the U.S. Department of Commerce, the Small Business Administration, the U.S. Department of Trade, and the Minority Business Development Agency. Many of these small companies were implemented and completed during my time as a special business in-kind consultant with the Honolulu MBDA during the past 3 years.
- I currently help an SDVOSB government contractor source government contracts such as Time & Materials, Cost Plus
  and Firm Fixed Price. I also assist this same client with his annual Provisional Rate Proposals and Incurred Cost
  Submissions to the Defense Contract and Audit Agency (DCAA) for approval. Submittals for 2020, 2021 and 2022 were
  especially challenging as narratives and adjustments needed to be made in those rate proposals and Cost Submissions
  in all areas of Overhead, G&A and Fringe reconciliations due to Covid programs EIDL and PPP. We sourced nearly \$5
  million in these SBA Covid programs which then needed to be properly applied to these programs to maintain competitive
  bidding rates for contracts. Needless to say, I am now quite proficient with these audits.
- I have a firm grasp of the U.S. grant system, not only Covid programs EIDL, PPP, Shuttered Venues, Employee Retention

Credit and the Restaurant Revitalization Fund, but also the Grants.gov and SAM systems. I helped source roughly \$8million in covid relief and currently have three FAA grants pending but also applied for Capital Readiness Grant and Tokyo PAS cyber grants. I help clients and NGOs apply for numerous grants as I understand the operational system and audit processes for grant administration. Most NGOs don't understand the laws, rules and tax laws that pertain to grants. Some of these grants and business are from applicants in the Pacific Islands. We are currently assisting clients look into and obtain 8(a), Women-Owned and NHO status here on O'ahu and on Guam an in the CNMI.

- I have an ability to present ideas, concepts, and complex situations through practical means in all communication styles. I've gained this through 30 years of client service operations, database management, statistical and financial modeling all through simple software such as Excel, Word, and PowerPoint, but also with more sophisticated software such as PhStat, QuickBooks and Salesforce for effective CRM. For clients we use cloud based software for creating marketing materials and producing video content. I am familiar with compliance and qualification for Cybersecurity Maturity Model Certification CMMC for DoD Contractors which entails and vast number of systems that need to be in place.
- I am Alumni of the powerful and respected University of Hawai'i, Shidler College of Business. Our alumni network of 29,000 spans 40 countries.
